5.1.2023 Library Budget submission

The Library CEO indicates that minor changes to some 2023 budget lines within existing dollar amounts will reflect operational spending needs. A new 'Staff Appreciation' budget line will be established for the Library's 2023 budget proposal.

The Library CEO acknowledges the recent donation from the Optimist Club of Mitchell of \$605 for March Break 2023 children's programming. The generous donation will be deposited into a reserve fund to spend in 2023.

6.1.2023 Board meeting dates and education topics

Board members review the 2023 meeting dates. Meetings will continue inperson on the fourth Tuesday evening of each month—except July, August, and December—at 6:30pm. Virtual meetings will be held instead of in-person meetings if necessary, to be determined on a month-by-month basis. Keeping the current Priorities will provide consistency for staff to implement programs, services, new collections and resources, and will allow the Library to develop fully the intended potential of each priority:
