## 5.1.2024 Valuing Ontario Libraries Toolkit (VOLT) Social Return on Investment

## 6.1. PCIN Board Meeting Update - May 15, 2025

The PCIN Board met virtually on Thursday, May 15. Discussion topics included staff cybersecurity training, Perth County Reads 2025, a preliminary 2026 PCIN budget overview, and an upcoming Memorandum of Understanding outlining PCIN library responsibilities. Board members requested a report this fall from Library CEOs outlining repair and replacement considerations pertaining to the PCIN delivery van.

#### 6.2. Library Board Report – Establishing the Library as a Corporate Entity

Municipal and provincial legislation requires that a public library is a corporate entity governed by its Board and separate from its Municipality. Establishing an integrated financial structure for West Perth Public Library within the Municipality of West Perth includes registering for a non-profit business number so that library tax and other financial filings are separate from those of the Municipality.

Once the Library is established as a corporate entity, its Memorandum of Understanding with the Municipality may need updating to reflect any resulting changes to Finance Department responsibilities.

- Family Services Perth-Huron continues monthly visits;
- Upper Thames Elementary School visits for Kindergarten and Grade One students have been arranged throughout the months of May and June;

- 'Summer Kids' Club' sessions and 'Library On Location' summer visits around town have been scheduled with local partner organizations, and will be posted on the Library's website shortly;
- Service Canada monthly visits at the Library will be shortened beginning in May, and may be reduced if demand decreases;
- Dungeons & Dragons sessions at the Youth Centre have wrapped up for the season, and will resume in the fall. Fall sessions may include other interactive games, as well, such as Star Wars.

West Perth Public Library is grateful to all volunteers and partner organizations who help to bring fun, educational, affordable programs and services for all ages into the community.
